# IDPO Report 2024

## Executive Summary

The International Digital Policy Observatory (IDPO) is a publicly accessible database that tracks developments in digital, internet, and emerging technology regulation across multiple countries. The IDPO is led by Professor Terry Flew with a team of interdisciplinary researchers from the University of Sydney, UNSW, and UTS, and is funded by a 2023 Australian Research Council Linkage Infrastructure, Equipment and Facilities (LIEF) grant. The IDPO has received over 5,000 visits to the website since its launch in April and has published four e-newsletters.

The IDPO has also been involved in numerous policy submissions, including submissions to the Joint Select Committee on Social Media and Australian Society, the ACCC Digital Platform Services Inquiry, and the Safe and Responsible AI in Australia inquiry.

Since its launch in April 2024, the IDPO has quickly established itself as a valuable resource for policymakers, industry stakeholders, and civil society advocacy groups who are seeking to better understand and respond to international trends in the tech policy arena.

# Introduction

The IDPO is a publicly accessible, real-time database with enhanced analytical tools that tracks developments in digital, internet, and emerging technology regulation across multiple countries. The purpose of this infrastructure is to shape innovative policy search and analysis techniques concerning multifaceted regulation, policies, and governance across our digital society and economy.

Through the development of such an enabling infrastructure, policy makers, industry stakeholders, and civil society advocacy groups will be able to draw upon a 'common pool' resource to better understand and respond to international trends in the tech policy arena. This International Digital Policy Observatory (IDPO) seeks to place Australia at the forefront of policy and regulatory debates globally.

This project is funded by a 2023 Australian Research Council Linkage Infrastructure, Equipment and Facilities (LIEF) grant which provides funding for research infrastructure, equipment, and facilities.

The IDPO is led by Professor Terry Flew with a team of interdisciplinary researchers from University of Sydney, UNSW, and UTS. A key project partner is the Australian Information Industry Association. This multi-university consortia and industry partnership has built the IDPO to place Australia at the forefront of regulatory best practice in the digital economy.

# Highlights

- IDPO Website
  - The team focused on the preliminary project development, website design, implementation, and testing from January through to April.
  - The IDPO was officially launched by The Hon Justice Melissa Perry at the law firm Gilbert + Tobin on 24 April 2024
  - Further website useability testing was undertaken from October and November
  - Enhancements are scheduled to be implemented December 2024 - January 2025
  - Datasets for Misinformation and AI Regulation were launched.
  - Cybersecurity and Online Content Regulation datasets are currently in progress for release in 2025
  - Four e-newsletters were published and distributed to industry and partner subscribers
  - Since launch in April the IDPO has received over 5000 visits to the website
- A new IDPO logo was designed and implemented in October 2024
- An A4 IDPO Introduction flyer was produced and distributed to over 250 Federal and NSW Members of Australian Parliament
- Wendy Lam was engaged through UTS to undertake data collection updates for misinformation and disinformation policy in the European Union (and EU countries) and the United Kingdom
- Chris Zhao was engaged as an intern for 140 hours. Key outcomes of this internship resulted in user testing of the existing website along with proposed useability enhancements.
